### 2020 Yukon River Salmon Fall Fishery Announcement #26 Subdistrict 5-D Lower Subsistence Fishing

Districts Affected: Upper Yukon Area

This year's fall chum salmon run fell below the 300,000 fish threshold needed to allow subsistence fishing. In accordance with the Yukon River Fall Chum Salmon Management Plan, subsistence fishing for fall chum salmon has been closed for most of the season. As the end of the 2020 fall chum salmon run is complete in Subdistrict 5-D Lower, subsistence fishing restrictions are being relaxed to provide fishing opportunity for other fish species.

**Fishermen in Subdistricts 5-D Middle and Upper should standby for announcements as the fall chum salmon run concludes in these areas.**

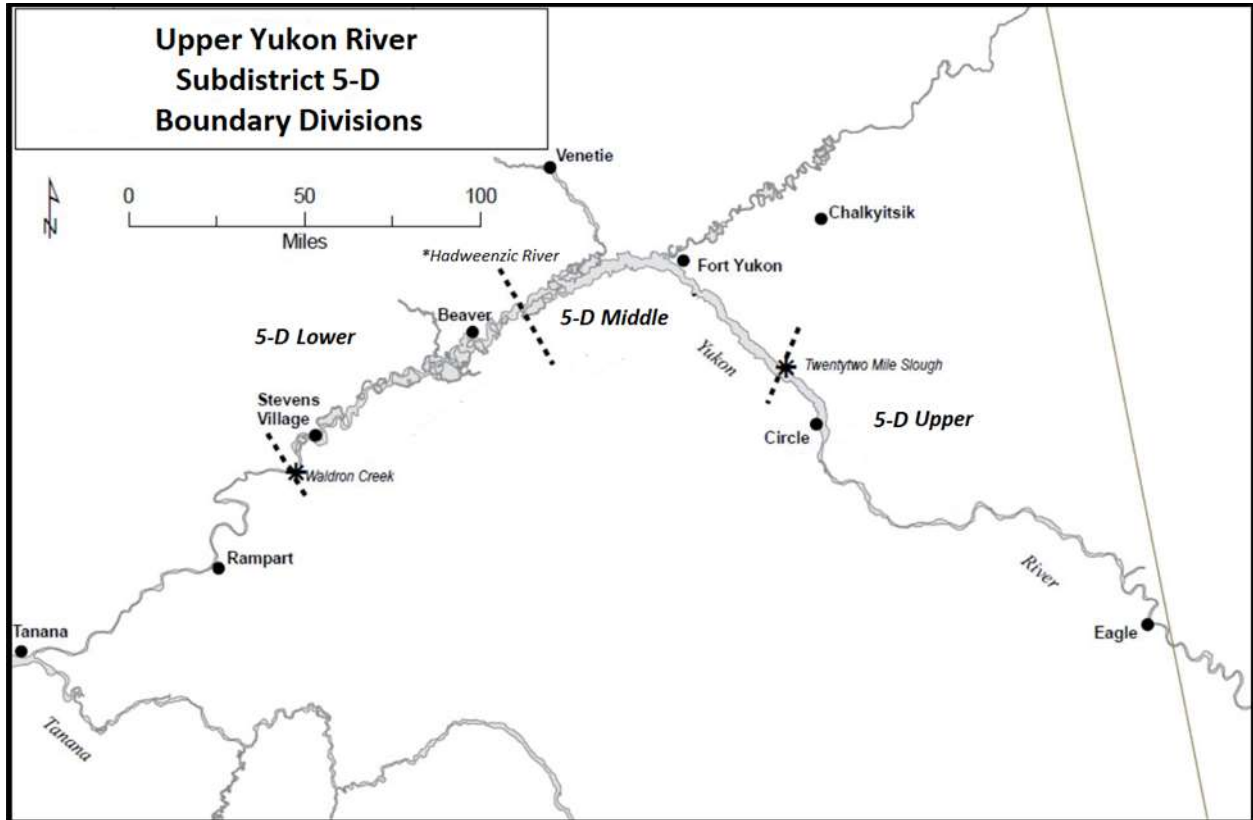
#### Subsistence Management Actions

**Subdistrict 5-D Lower** (from an ADF&G regulatory marker two miles downstream of Waldron Creek to Hadweenzic River, includes Stevens Village and Beaver):

Subsistence salmon fishing is closed. Fishermen may use 4 inch or less gillnet gear to target non-salmon species.

**Effective 12:01 a.m. Tuesday, September 29 subsistence fishing will open for 24 hours per day, seven days per week with 7.5 inch or smaller mesh gillnets.** Fishermen may use other types of gear such as dip nets and fish wheels. All fish caught may be retained.

A subsistence permit is required to fish for all species in the portion of Subdistrict 5-D Lower from an ADF&G regulatory marker two miles downstream of Waldron Creek upstream to the mouth of Dall River. Subsistence harvest calendars and subsistence fishing permits are available from the Alaska Department of Fish and Game Fairbanks office (459-7274) or online at [www.adfg.alaska.gov/store/](http://www.adfg.alaska.gov/store/).
