Why is the Yukon Rive Panel developing a Rebuilding Plan?





Background

- Chinook salmon in the Yukon River have declined to critical levels.
- The 7-Year Agreement, signed in April 2024, specifically requires development of a Rebuilding Plan.
 - It is expected to incorporate traditional knowledge as well as scientific evaluation
- The Yukon River Panel is responsible for developing the Rebuilding Plan
- We have been retained by the Panel to support them in developing the Rebuilding Plan.

What is the Rebuilding Plan?

- Comprehensive plan to restore Yukon River Chinook Salmon populations through <u>actions</u>
- Incorporates the ecological needs of salmon and the cultural and social needs of the people that depend on salmon
- Focuses on the entire life cycle of Chinook salmon Developed based on proven and emerging approaches








Process

- Guides the overall development of Rebuilding Plan
- Scope, Objective, Values, and Principles
- Roles and Responsibilities
- Decision making processes
- Outreach and communication






Socio-Cultural

- Emphasizes the importance of the relationship between people and fish
- Background: human-dimension context
- Indigenous, other communities and users, and gov't
- Stewardship, cultural practices, land guardians
- Cultural camps, food security, youth engagement






Technical

- Well-recognized approach, tailored to Yukon River
- 3 questions:
 - What is the status of the population?
 - What caused the decline in the population?
 - How do we stop the decline and reverse the trend?
- Builds on existing information





Technical


- Status Report
 - Population, life history, habitat, information gaps
- Threat Assessment
 - Life cycle model, sensitivity analysis, uncertainty
- Recovery Actions
 - Prioritized by effectiveness, feasibility, cost, social barriers
- Implementation and Monitoring

 - Support from existing work in AK and Yukon
 - Public engagement

Progress to Date

- Ecofish hired as facilitator (October 2024)
- Three YRP Special Session meetings:
 - Fairbanks (November 2024)
 - Anchorage (January 2025)
 - Dawson City (April 2025)
- Development and endorsement of Process, Socio-Cultural and Technical Frameworks
- Establishment of Steering Committee Concept



Progress to Date

- Scope characterized as "gravel to gravel"
 - Entire salmon lifecycle
 - River, watershed, marine
 - Fisheries
 - Land use
- Objectives, Values, Guiding Principles
 - Sets the foundation for the Rebuilding Plan and a guidepost for where we're going




